<u>Grounds Report</u>: Attached. Toby and Eric did a very professional job painting the curbs and marking fire lanes throughout the complex. This satisfied the Federal Way fire department's requirements and passed inspection.

<u>Water Shutoff Valves</u>: Susan has dedicated a tremendous amount of time requesting water connection blueprints for a few buildings. Attempts to date have been mostly unsuccessful. King County was able to locate the original water permit, which Susan will take to Lakehaven for a follow-up. Some shutoff valves are in difficult locations and need to be relocated. Only a few units are impacted.

Roofs: Roof Maxx recently removed moss and treated the shingles on buildings 11, 13, 20, 22, and 27. The Board approved removing moss and applying moss control on five additional buildings: 1, 2, 3, 10, 15, and 16.

Resident Garden: The Board approved a written request for a resident garden at Building 15, Unit 6. The residents provided photos and plans for what they intend to grow in that area. **Residents who want to maintain a certain space associated with their unit must contact the Board in advance for approval.**
